First Selectman's Corner

With the holidays approaching, I want to wish everyone a Merry Christmas and a Happy and Healthy New Year. And to kick off the season, please attend our annual Holiday Parade and Tree Lighting, as usual, on the Saturday after Thanksgiving, November 29th this year. It's important to note that the parade will begin at 6:15 pm, not 5pm as in past years. The parade will follow the traditional route from Branford High School along East Main and Main Streets to the green, where Santa and Mrs. Claus will arrive by fire truck to light the tree. We hope you, your family and friends can make it.

As winter approaches, our infrastructure efforts continue to progress. The decking for the new School Ground Road bridge was set in place and assembled in late October followed by the abutment construction and other structural components, keeping as close as possible to the targeted open date. And with state plans to replace its Rte 139 / North Branford Road bridge, we are working with DOT to keep that project's timeline as short as possible and traffic disruption to a minimum.

Meanwhile, the state is working to complete the pedestrian bridge connecting the new commuter drop off lot on the north side of the tracks with the main platform and station on the south side. These improvements are critical for Branford as Shore Line East rail service to New Haven improves.

In the center of town, pass by the corner of South Main and Montowese Streets and you will see that work has begun on the Academy on the green. In the hands of Branford's own M. N. Reale Construction, the bell tower has been removed for repair and reconstruction at the company's workshop on Meadow Street. When completed and re-erected atop the building next spring, the restored Academy and the new brick walkway wrapping around that corner of the green will further enhance the appeal of our Town Center historic district as a destination and focal point.

And not far from the green, plans are moving forward to repurpose the Atlantic Wire property on Meadow Street from a circa 1900 wire mill to a 21st century transitoriented development with mixed use of residential and commercial space. Located in the town center, it will be a short walk from "Atlantic Wharf" to the Community House and other public venues, to the green with surrounding restaurants and shops, as well as to the train station and the new Stony Creek Brewery.

Also, please remember that this year is a "reval" year



for Branford and that the best way to have a thorough property revaluation is with the cooperation of all property owners. Please feel free to contact the Assessor's office with any questions.

Finally, I want to take this opportunity to congratulate Chief Jack Ahern of the Branford Fire Department on his retirement at the end of this year and to thank him for more than 35 years of service to the town. Jack represents the best of Branford, and we have been

In continuing to support its philosophy of *"Recreation... where the benefits are endless"*, the Branford Recreation Department dedicates itself to running programs, both active and passive, to promote a positive and healthy lifestyle for all, especially during this busy and festive Winter Season.

Starting in January, the department provides movement and rhythm classes and music classes for Toddlers ages 12 months to five years of age Tuesday to Friday mornings. 
Branford Economic Development Commission

At its September meeting the Branford Economic Development Commission presented Brewer - Bruce & Johnson Marina with its "Business Recognition Award". The EDC periodically presents the award to a Branford business that is a leader in its field and that contributes to making Branford a better place to live and work.



Located on the Branford River since the 1960s, Bruce & Johnson's offers 500 slips at its 16 acre Block Island Road facility, and another 150 slips at its new west yard facility on Goodsell Point Road. The marina offers boat storage, repair and maintenance services to season guests and boats in transit by a staff of 20 full time professionals, many of whom have been with the company for decades. The marina operations include the popular Dockside restaurant, outdoor recreational space, and ongoing educational and community programs. The Commission also recently met with the "Atlantic Wharf" development team to review and comment on their plans for the 7-1/2 acre former Atlantic Wire site along Meadow Street, between Montowese and Church Streets. Located two blocks from the town green, along the Branford River and a half mile to the expanding Branford train station, it is designed as a transit oriented development project that will include 205 residential units and approximately 24,000 s/f of ground level commercial space.

A life-long Branford resident, Maresca joined the commission in 2009 and owns and operates Affordable Lighting Center and Sound Lighting & Design, located on Business Park Drive.

The Branford Counseling Center (BCC) is a municipallyfunded behavioral health and social services agency, providing services to Branford residents, both adults and children. BCC is the Youth Service Bureau and Social Services Department for the Town of Branford. Licensed by the Connecticut Department of Public Health, clinical services are provided by licensed professionals. BCC is a Medicare and Medicaid provider and most commercial health plans are accepted. Our exceptional staff of qualified personnel will help all clients and no resident will ever be refused treatment because of an inability to pay. It is the mission of the Branford Counseling Center to maximize treatment through collaboration with other local agencies, schools, hospitals, private practitioners, and various town departments.

While the business of the summer and fall are behind us, winter has a lot in store as well. By far our biggest program of the year, the Secret Santa Program, is already in the works. Last year we were able to connect more than 600 individuals and 350 families with our hundreds of generous donors. In addition to the donors, the Secret Santa Program grows more and more each year with the help and hard work of our staff and volunteers. They work countless hours to make sure every family has a joyous holiday. As we all know, winter and the holidays can be difficult financially for many individuals. These needs extend beyond the ability to buy gifts and leave some struggling to be able to afford the basics, such as food or heat. It is for these individuals that, especially this time of year, BCC's Basic Needs Program is vital. The program offers short-term assistance to individuals and families who find they are struggling due to life changing circumstances. The program helps qualified individuals and families with temporary rental assistance, energy shutoff notices, and food cards. The program receives over 3,500 calls per year with less than 10% actually getting help due to the program's financial restraints. A portion of the funds to support this program comes from the Town budget and through fundraising events or donations.

One of the ways we hope to make our programs, such as Secret Santa, and other events even more successful is through our newly renovated Town website (http://www.branford-ct. gov/Counseling) as well as BCC's new Facebook page (https:// www.facebook.com/BranfordCounselingCenter). The website provides basic information on the services offered by BCC and the Facebook page has become a great tool to keep the community updated on events, fundraisers, and other announcements.



Don't Be Fooled by a Pbony Utility Worker

The Branford Police Department has recently investigated several cases of phony utility workers attempting to enter homes and stealing personal belongings and money. Someone may appear at your door claiming to be a



utility worker, saying they need to inspect your water pipes, check your meter, investigate a gas leak or examine the wiring in your house. The person at your door may be carrying a walkie-talkie and wearing a hard hat and vest to appear legitimate.

So how can you tell a real utility worker from a scam artist? The key is to be cautious and ask questions. If you don't, you could unknowingly invite a thief into your home.

Posing as a phony utility worker is a classic scam that often targets seniors living alone. If you remain alert, you'll spot the warning signs that will help you avoid becoming a victim.

This type of scam is also known as a distraction theft because the victim's attention is cleverly diverted just long enough for the thief or his accomplice to rifle through the victim's house helping himself to money, jewelry and other valuables. In order to distract the victim, the imposter may ask you to step outside. Or he may ask you to go to another part of the house to turn the water off or bang on the pipes. These are all ruses to distract the victim's attention and give the thief time to ransack your house looking for loot to steal.

In order to avoid becoming a crime victim, here are some things to keep in mind when you get that knock on the door from someone claiming to be a utility worker who needs to get into your house:

• Stop and think: Are you expecting anyone to come to your home? Remember that most utility companies won't send a worker to your home unannounced. They usually will make an appointment before showing up.

• Before opening the door, use your peephole or intercom to identify visitors.

• If your door has a chain, put it on before answering your door. It will create a barrier between you and the caller.

Always ask to see the caller's employee identification.
Look for a company logo on the person's

uniform and vehicle.

• Call the utility company to verify the person's identification. Make sure you have the person wait outside behind a locked door while you do this. A legitimate worker won't mind waiting while you verify their employment information. The utility company will be able to tell you whether the person is an employee and whether they've dispatched a service call to your home or neighborhood.

If the person is an imposter, contact the police immediately.

From the Assessor

TOWN OF BRANFORD REVALUATION 2014

The Revaluation process for 2014 is proceeding as planned and the assessment notices will be sent the first week of December 2014. At this time, during the 2014 Revaluation process the following procedures have been completed: Data Collection for Data Mailer Changes, Building Permit Inspections, Review Analysis of Sales, Cost and Land Analysis, Income & Expense Review, Commercial Market Rate Analysis and Table Calculations. Where necessary the majority of the photographs have been updated. This is an ongoing process as owners update their buildings every year with changes.

The first week of December 2014, notices will be mailed. When you are reading the notice you will see a toll free telephone number to call. Telephone only if you wish to have an appointment for a hearing. It is a Vision Telephone Number in Northboro, MA. During your hearing they will address questions you may have or issues you wish to discuss or have clarified or changed. Please do not telephone the Assessor's Office for an appointment. The Schedules are kept in Northboro and they have all the Dates and Times. You must telephone by December 12th, 2014 to have an appointment for a hearing on any parcel with Vision. Please bring any information to support your request for a change. Hearings with Vision will be held in the Branford Town Hall.

When the Vision hearings have been completed all property owners who have had hearings with Vision will receive a second notice.

The property owners may view their 2014 Data on the Vision Appraisal Web site. It would be good to verify this data. The Vision Web site is as follows: www.vgsi.com. There is also a link through the Town Web Site (www.branford-ct.gov) to this web site. See Assessor's Department and then click on Assessor Field Cards. Sales are also available on the Assessor's Department web site.

You will only be able to retrieve the old field card at the Assessor's Office in the Town Hall. This 2013 field card has been updated with current building permit changes and any inspections that have occurred on the parcel since October 2009, which was the last Revaluation. You will also be able to print the 2014 Revaluation Field Card in the Assessor's Office.

The Assessor's Office, Vision Government Solutions and

the First Selectmen will be filming a short educational and informational program on the 2014 Revaluation. It will run on BCTV after the notices have gone out and through at least the month of December. I will also try and have it loaded on our Web Site under the Revaluation Section.

We will try and have Neighborhood and Sales Maps available at the Hearings. There is a great deal of data available on the Web Site and in our office. We have printed Sales Books.

I would also like to THANK the many Branford Homeowners who have worked with the Revaluation Company for Inspections on Data Mailers, Sales Verifications and Building Permits. If you were not available at the time of the inspection, letters were sent and many of you responded with appointments. We are very grateful to the many of you who took the time to respond. 
Remember, these notices and hearing dates are for All Properties.

Remember this is the first step of the hearing process. The second step is with the Board of Assessment Appeals in February 2015. The final step is Court.



Klezmer Concert at Branford Folk - December 13

The Branford Folk Music Society will sponsor a special Hanukkah concert and dance party with internationally renowned klezmer musician and composer Pete Rushefsky and his Ternovka Ensemble on Saturday, Dec. 13 at 8 p.m. in the auditorium of the First Congregational Church of Branford, 1009 Main Street on the Branford Green.

Rushefsky is recognized as a leading performer of the tsimbl (cimbalom), the traditional hammered dulcimer of klezmer music. Rushefsky and bandmates will provide a musical tour of the shtetls and cities of Eastern Europe that formed klezmer's wellspring and trace its evolution to the New World. Branford Folk's own renowned dance leader Willa Horowitz will teach dance steps at the end of the concert, turning the event into a pre-Hanukkah party.

A resident of New York City, Rushefsky is currently touring with violinist Itzhak Perlman in a program/recording titled "Eternal Echoes: Songs and Dances for the Soul", featuring the leading cantor Yitzchak Meir Helfgot, as well as klezmer revival legends Hankus Netsky and the Klezmer Conservatory Band. Rushefsky serves as executive director of the Center for Traditional Music and Dance in New York City, a not-for-profit organization dedicated to preserving and nurturing the performing arts traditions of the city's immigrant communities. He has been featured on PBS's Great Performances, National Public Radio's Prairie Home Companion, All Things Considered and American Routes, as well as Radio One France.

A popular instructor at Yiddish folk arts camps internationally, Rushefsky authored a pioneering instructional book on adapting the American 5-string banjo for klezmer, and an upcoming book on klezmer performance for hammered dulcimer. He is a well-known lecturer on klezmer and other traditional music, with a number of published articles to his credit.

The klezmer concert is part of the non-profit Branford Folk Music Society's 40th Anniversary concert season. The society will open the New Year with Karen Ashbrook and Paul Oorts on Jan. 10. Ashbrook is another renowned hammered dulcimer player who also plays flute and pennywhistle while her spouse is a Belgian-born fretted instrument master. Their collaboration mixes Irish, Scottish, Flemish and French music.

The Musical Art Society of Branford

The Musical Art Society of Branford is a cultural arts group that was founded in 1920 by Alice Collins and a group of local music teachers. (In 1919, Alice married Jeremiah J. Collins who was an owner of the Collins & Freeman Hardware Store in Branford, where Alice resided until her death in 1972). The original group met monthly in members' homes for their own musical entertainment. In past years, auditions were required for membership, but in recent years the group has expanded to include not only musicians but all music lovers, and auditions are no longer held. New members are always welcome! Dues are \$20 per year for an individual or \$30 for a household, and new members can join at any concert or by contacting a member.

The mission of the group is to promote and support excellence in music in the community. They occasionally meet in private homes for concerts and musicales, but most often present diverse artists in public spaces such as the Blackstone Library and various churches and concert halls in town.

The group gives a music scholarship each year to a graduating high school senior planning to study music at the college level, funded by members' dues, donations, and an annual scholarship fundraiser concert. In its first year, the program directly resulted in an additional 18 tons of materials being recycled that otherwise would have been burned as trash! Many thanks are due to Etta Hanlon, a Branford High School student, for her hard work in bringing her concept to fruition.

Specially marked bags will be available at various locations throughout town, including Town Hall, the Senior Center, our Libraries, Community House and the Transfer Station for collecting your recyclable holiday paper.

Simply fill your bag as you open your gifts (please see below for a list of acceptable materials). And then place your filled bag(s) out with your normal recyclables for collection, or bring them directly to the Transfer Station. If you do not have one of the specially marked bags, your holiday paper can still be recycled by placing it in the same bag/ bundle as your newspapers and magazines.

We must stress that only paper products can be placed in these bags. Wrapping paper made of foil or plastic (Mylar) are not acceptable. Neither are ribbons or bows that are not made of paper. A good rule of thumb is, "If it rips, it fits."

Branford Water Pollution Control Facility

Branford Water Pollution Control Facility - when flushing ... It is human nature to dispose of all kinds of waste to the commode, including but not limited to the occasional dead goldfish. With a wide mouth and relatively powerful drainage, it's tempting to use the toilet like our own personal trash transporter: just dump, flush, and it's gone forever.

There are many things that should NEVER be flushed down the toilet. To direct these materials via the toilet drain is to risk significant plumbing problems for you and the Branford Water Pollution Control Facility (municipal sewer system which includes a centralized treatment plant and over 100 miles of sewer lines) which can lead to environmental pollution affecting our natural resource, such as the clam beds.

Towels, cloth items, and bathroom wipes - they're just cotton, right? It might seem like these things would just get soggy and eventually break down in the watery pipeline, but they don't. They eventually gather together in bends of the pipe, causing massive blockages. Despite the fact that the bathroom wipes are marketed to be flushed like toilet paper, these wipes are creating clogs and backups in sewer systems around the nation.

Fats, oil, and grease: this is a tough one, and everyone has done it at one point, but cooking fats should NEVER go in the drain or garbage disposal. It seems like a liquid when it's hot, but as soon as this grease hits the drain, it cools and congeals, becoming pipe-clogging wax. Scrape it into the trash or, if it's clean bacon fat, save it in a jar for reuse.

Rainwater - The discharge would at first seem to pretty

small, but it isn't. With a typical storm, the flow to the municipal wastewater plant can double or triple due to illegal stormwater tie-ins. The increase flow is expensive and interferes with proper treatment. In Branford, we run a "separated system", that is stormwater directed to a drainage system and municipal wastewater is directed to the plant for treatment.

Prescription Medication - Don't need the rest of those pills? Many people feel like they're doing the safe thing, keeping meds out of the wrong hands by flushing them, but it's actually very dangerous. These drugs (when improperly disposed of) destroy bacteria used in the biological treatment of the municipal wastewater, contaminates groundwater and surface water supplies, and can have terrible effects on wildlife downstream.

Chemical liquids - Any corrosive or flammable material (including painting supplies, fertilizers, herbicides and/or pesticides) should never be directed to the municipal sewers. These products are extremely toxic and will interrupt the secondary (biological) process at the treatment plant.

Cat litter - I can understand how this would seem ok; but cat litter is made from clay and sand, two things that you should NEVER put down a toilet. Not to mention that cat waste contains toxins and parasites that shouldn't be in our water system.


Brian's Hope


Make a Kit to last you 3 days... Water (1 gallon per person per day) Non-perishable food: Peanut butter, tuna, soup, crackers, etc. **Items:** Flashlight, radio, first aid kit, medications, all-purpose tool, cell phone with battery charger, cash, list of contacts, and a blanket.

Make a Plan: Your plan should include: a list of contacts, an evacuation plan in case you have to leave, an out-of-town contact for everyone to get in touch with if they are alright, and a knowledge of the safe places in your home in case of harmful weather.

Stay Informed: Sign-up with B-Informed on the Branford Town website (www.Branford-ct.gov) so the town is able to send you voice messages and email messages during emergencies. Also sign up for CT-Alert on the State of Connecticut website (www. CT.gov), a similar alert system run by the State for state emergencies.

Stay safe from the flu and other infectious diseases: Wash your hands, sneeze or cough into a tissue or into your elbow, and Get Your Flu Shot.
