### First Selectman's Corner

I hope everyone had a wonderful holiday season and I wish everyone a healthy and happy New Year. Now that winter is upon us I want to remind everyone to be extra careful when traveling our roads and to be mindful of our winter ordinances related to snow removal and parking. Within 24 hours after a snowstorm is over, property owners must have their sidewalks cleared. There is an "Overnight Parking Ban" in effect from December 1st through April 1st. There is no on-street parking between the hours of 1:00 a.m. and 7:00 a.m. or whenever snow removal operations are in progress. The Fire Department also requests if you have a fire hydrant in front of your property, you keep it free and clear of snow in case of emergencies. In addition, please do not plow snow into the roads. We need everyone's cooperation in order to clear the roads quickly and make sure all the roads and sidewalks are safe for vehicles and pedestrians.

I am happy to announce that the Town of Guilford was recently recognized by CERC (Connecticut Economic Resource Center) for the Guilford Commons development. The Town has applied for a state matching grant in the amount of \$68,000 to help with weed control at Lake Quonnipaug. Invasive weed growth has been an ongoing problem, which the town has been continually trying to address. This grant will help us begin a program to annually control the growth of the weeds. We should receive a response soon as to whether the town has been awarded the grant.

The Guilford Lakes Golf Course Commission has completed the renovation of tees 1, 3 and 4 this fall, which now completes the reconstruction of all the tees on the course. Next spring these tees will be in play as well as the tees that were reconstructed last year. As a side note the Board of Selectmen has approved a request for proposal to be published seeking proposals from companies interested in possibly take over management of the golf course in the hopes of producing better financial results. One of the conditions of the RFP is that the management company must maintain the excellent conditions of the course, which is still rated as the number one par three 9-hole courses in the state and the third in New England.

### **Assessor's Office**

Elderly Tax Relief applications will be taken in the Assessor's Office, between February 1st and May 15th, during the hours of 9:00 am and 4:00 pm, Monday through Friday. If you are unable to come in, an agent of your choice may file on your behalf. Please bring all proofs of income for both spouses (for the year 2015), including (but not limited to) your Federal Income Tax Return (if you file or will file), your Social Security (SSA-1099 Form) annual statements, statements of pension, interest or dividends, etc. All information must be in English and U.S. dollars.

#### THE BASIC REQUIREMENTS for all of the following Elderly Tax Relief Programs are as follows:

- The homeowner must have owned the property as of October 1, 2015.
- The homeowner must be at least 65 years of age as of December 31, 2015 or was receiving 100% disability benefits from Social Security as of that date;
- The homeowner must have lived in Connecticut for at least one year;
- The homeowner must not be receiving tax relief from any other town or state;
- The homeowner must occupy the property as their principal residence.

### HOMEOWNERS PROGRAM, A.K.A. CIRCUIT BREAKER (STATE PROGRAM)

Under this program, the State of Connecticut pays a portion of your tax bill ranging from \$150 to \$1,250. There is no requirement to re-pay the State.

The homeowner must have income (including Social Security) of not more than \$35,200 for a single individual or \$42,900 for a married couple.

### TAX DEFERRAL, A.K.A. GSTRP (TOWN PROGRAM)

This program allows you to "defer" up to 75% of your taxes (depending upon income) until either the property is transferred or at the time of your death (at which time the taxes must be re-paid with interest). The deferred taxes constitute a lien on your property.

The homeowner must have income (including social security) of not more than \$37,200 for a single individual or \$44,900 for a married couple.

### ELDERLY TAX RELIEF PROGRAM, A.K.A. ETRP

### (TOWN PROGRAM)

Under this program, the Town attempts to "freeze" your taxes subject to budgetary restrictions and the requirements of the enabling ordinance.

- The homeowner, if eligible, must be on the State Program known as Circuit Breaker (see above);
- The homeowner must not owe any taxes (including motor vehicles);
- The homeowner cannot be on both the Town's Tax Deferral and this program; and
- The homeowner's income is based upon residency (as follows):

Years of Residency	Single	Married
1 to 4 years	\$29,600	\$36,000
5 to 8 Years	\$44,500	\$54,000
9 to 20 Years	\$62,500	\$75,000
21+ Years	\$79,000	\$95,000

### 2016 CITIZENS POLICE ACADEMY

The Guilford Police Department is seeking participants for the 2016 Citizens Police Academy beginning Thursday, March 24th through Thursday, May 26th 2016. As the Department strives for transparency, the Citizens Police Academy provides a hands-on opportunity to educate the citizens of Guilford on the operations of the Department while obtaining valuable feedback from citizens to enhance police and community relations.

The 10-week Citizens Police Academy will include over 30 hours of instruction taught

in 3-hour sessions every Thursday evening from 6pm to 9pm. We ask that participants commit for all 10 weeks to complete the program. The training includes interactive classroom participation, a department overview, elements of crimes, laws, a range day; patrol ride-a-long, K9 demonstrations, federal and state agencies. Classes will be held at the Police Department Community Room located at 400 Church Street.

If you have questions, contact Detective Jakober in the Crime Prevention Unit at 203-453-8061. Applications will be at the Department, on our Facebook Page, and on the Guilford Police Department website: www.guilfordpd.com. The deadline for applications is March 14th, 2016 and the class size is limited to 30 people. Participants must be Guilford residents and 16 years of age or older. Sixteen and 17 year olds must have written permission from a parent or guardian to participate. A standard background check will be completed on each applicant.

### **IRS SCAMS**

This time of year, IRS scammers are looking to steal your money. Thousands receive letters, phone calls and emails

indicating that they owe back taxes and will be penalized, both criminally and financially, if they do not pay the amount due immediately. The written correspondence appears legitimate with IRS letterhead formatting and personal information. The phone calls are equally convincing and very intimidating. The truth is, the IRS will not call, email or send a letter of that nature in a not certified fashion. The IRS will want to know if you have received a letter and document the contact via certified return/receipt letter. If you receive some type of correspondence from the IRS or a call from someone claiming to be the IRS, contact the IRS directly via the online listed number, not the number listed in the letter, email or phone call. Do not give out your personal information. If they are calling you, they will have it. Tell them you will call them back on the number listed for the IRS online or in the phone book. Often times, the caller will hang up as they have realized that you have been educated on the scam and will not be a willing victim at that point.

Taking the extra step to determine if the IRS contact is legitimate will save you, possibly thousands of dollars, down the road. The IRS website has a list of known common scams associated with their agency. What you should know, is that this scam list is evolving almost daily as scammers out there seek to relieve you of your money in new ways. ### **COMPUTER SCAMS**

Have you received the call from "Microsoft" claiming something is wrong with your computer and they need access to it to fix the "bug"? It's a scam. Microsoft will not call you to fix anything. The caller is attempting to gain access to your computer for one of two things. Either they are accessing your computer to take information from your hard drive or they are downloading a "keystroke virus" that will document your login and password information for banks, email, or other sites that contain personal financial information. They will use this information to steal your identity and wreak havoc on your credit. Have you ever heard of "click bait"? The scammers are hoping you haven't and are fishing for victims with links they send in emails or videos on social media. Click bait is something as simple as an article with an interesting title that you 'click' your computer mouse on to view. While you are viewing the link, the virus is spreading throughout your computer. The viruses vary. Some just steal your email contact lists or social media contact lists. Others access personal information and search for usernames and passwords for online banking, insurance and tax sites. Don't fall victim to this scam. If you don't know who sent the email, if the email looks suspicious from someone you do know or if the article or video is not from a trusted source, DON'T OPEN IT. Just delete it or skip over it on social media. Make sure your anti-virus software is up to date on your computer and if you think your computer may have been accessed,

disconnect it from the internet and bring it to a computer expert to make sure it is not infected.

Have you ever typed in the wrong website into your browser? For instance, googlle. com instead of google.com. Hackers are counting on you to misspell websites and then will send you an alert that you have a virus on your computer. The alert looks official, like it was sent from Microsoft or Apple. However, the virus alert is false and the scammers are trying to get you to click on the link they provide or call the number they provide to get access to your computer. If you see this happen, close your browser and disconnect it from the internet. Clear your browser history, clear the cache and cookies. Reboot the computer and you should be fine. Again, make sure you have up to date virus protection on your computer. There is no definitive way to protect from all viruses and scams but the most important tool for computer safety is educating yourself on the scams and viruses out there. These criminals are lurking out there and waiting for someone to fall into their trap. See the Federal Trade Commission's website for further information on scams and computer crimes: http://www.consumer.ftc.gov/ To report these types of crimes go to http://www.ic3.gov to make sure the complaints are tracked and investigated. ### 2016 IS A HUGE ELECTION YEAR


There will be many opportunities to vote in 2016! We will begin with our yearly budget referendum on April 19, followed just a week later, April 26, with both a Democratic Presidential Preference Primary and a Republican Presidential Preference Primary. In order to be eligible to vote in one of these primaries you must be an enrolled member in either the Democratic or the Republican party.

Unaffiliated voters will NOT be permitted to vote in a primary. Party affiliations can be changed before the primaries, but there are several deadlines which will be strictly enforced. If you plan to change from one party to another, it must be done on or before January 26. April 21 is the deadline for unaffiliated voters to change to a party and for new voter applications by mail. April 26 at noon is the in-person deadline for unaffiliated voters to change to a party and for new voter applications. Party primaries to choose candidates for state and local offices will be held on August 9, if needed. The presidential election is slated for November 8. Again this year, the Registrars of Voters will be conducting an annual Canvass during the months of February to June. All voters with an active forwarding address order on file with the US Postal Service will be targeted to receive Canvass letters from our office. Additionally, voters for whom we have received information that they no longer reside in Guilford will also receive Canvass Letters. Also those individuals who have not voted in the last four years will be getting a letter, just to make sure you still live in Guilford! Please return these letters to us (using a prepaid return address envelope). If you do not indicate that you still remain in Guilford, we will start the process of putting you in "inactive" status.



### **Heating Assistance**

Guilford residents may apply for 2015/2016 State Heating Assistance (LIHEAP, CHAP) Program and for the Operation Fuel Program, by appointment only at the Guilford Social Services Department, 263 Church St. in Guilford. All types of heating sources are considered: oil, gas, electric, propane, kerosene and wood.

Annual household income limits are based on last 4 weeks of income and size of household: 1/ \$33,132; 2/\$43,327; 3/\$53,521; 4/\$63,716; 5/\$73,910; 6/\$84,105; 7/\$86,016; 8/\$87,928. Some assets limits do apply. Guilford residents should schedule an appointment by calling 203-453-8009.

A popular paw treatment allows the dog's feet to soak for ten minutes and is followed up by a grapeseed oil paw massage.

If you chose to leave your pet's hair longer in the wintertime don't forget to brush and comb thoroughly! Visit your groomer and make sure you are using the right tools. Dogs who don't get brushed and combed properly will get tangles that lead to matting. When this happens groomers have no choice but to do a short shavedown, something your pet's won't appreciate in winter!

### **Quarry History**

When we think about Guilford history we tend to use 1639 as a starting point. Our most famous natural resource however takes us back about 600 million years earlier. A molten mass of stone which never reached the surface of the earth cooled & formed a granite which is a variable pink color. As the gigantic mass of the earth's surface began to separate and form our continents, this magma of pink granite split into three parts one of which came to form the bedrock between Guilford Point and Pine Orchard.

In 1869 John Beattie came to Leete's Island to purchase his first parcel of land. He was a master stone mason and over the years grew his quarry business to be the largest and most successful of its kind in the Northeast. In 1884 he was granted the contract for the Statue of Liberty. At that time his 700 plus workers from the British Isles, Scandinavia, Western & Eastern Europe all worked to quarry, cut, process and transport each stone from Leete's Island to Bedloe's Island to form the pedestal as it was designed.

When the corner stone was put into place in August of 1884, before the six ton piece of granite was lowered, the Leete's Island workmen emptied their pockets of coins and tossed them into the mortar as their signatures of tribute, pride and thanksgiving for the recognition of their labor and the promise of a better future in their adopted land.

Mr. Balestracci and Mr. Anthony "Unk" DaRos, both descendants of quarry workers, give talks and tours of the history of the granite quarries in Guilford and Branford, twice each year. These are done at the Stony Creek Quarry. Proceeds benefit the Stony Creek Museum and the Guilford Keeping Society.



Mr. Balestracci will complete a research paper on the Beattie Quarries in the spring of 2016.



### **Cat Owners**

Inappropriate elimination or house soiling is a common frustrating problem faced by many cat owners. Medical conditions that cause pain or difficulty while using the litter box can lead to house soiling. They include urinary tract infections, intestinal disorders (colitis, inflammatory bowel disease), diabetes, kidney and thyroid diseases, and aging changes such as arthritis. Any cat that suddenly develops



an elimination problem should be thoroughly evaluated by a veterinarian as soon as possible to alleviate discomfort and resolve the undesirable behavior.

Non-medical reasons for cats to develop house soiling behaviors can include stress from environmental changes or family dynanamics, but most commonly have to do with the litter box itself. Frequently, the problem is that the litter box is not clean enough. Cats have a very sensitive sense of smell and are easily deterred from using the litter box by even the smallest amount of soiled litter - or some of the scented litter products. The ideal way to keep the litter box acceptably clean is to dump all of the litter, clean the box with a mild detergent and replace with fresh litter every day. This is made more economical by using a shallow layer of litter. Alternatively, with clumping litter, the clumps can be scooped out twice a day and the entire box dumped and cleaned weekly. Avoid using covered litter boxes as the cover concentrates and traps odors inside the box.

Be sure to have enough litter boxes. The general rule of thumb is to have one box per cat, plus one extra, to ensure that there will be at least one clean box at any given time. Choose a spot thoughtfully, keeping in mind cats tend to avoid eliminating close to their food, water or bedding. The location should be fairly quiet and somewhat private and easy to get to.

House soiling can be a very difficult behavioral issue to correct and can result in expensive damage to a home, but taking steps like the above can help prevent your cat from developing a permanent aversion to the litter box.





### **VISTA Members Publish Memoirs**

Four members of Vista Vocational & Life Skills Center have accomplished a feat many have only dreamed about publishing a book. Evan Brookman, Matt Christiaanse, Devery Morgan and Dana Rupley recall memories, life experiences and even look to the future in memoirs they wrote and published during a seven-week Vista Arts Center class taught by writer Jocelyn Ruggiero. These newly published authors shared passages from their books on Nov. 12th during a reading held at CREATE Art Studio in Madison.

"I liked telling my story to my family, friends and Vista staff," said Dana. Her memoir, *Pieces of My Life*, recounts her early years at Vista and includes anecdotes about loved ones. "I feel a sense of accomplishment."

In his memoir, My Life at Vista and Beyond, Evan, too, focuses on his time at Vista. He chronicles his journey through the program - from the nerves he experienced his first week, to the confidence and friendships he has developed over the years. His book also serves as a tribute to his late grandmother, of whom he shares fond memories. "I thought making part of [the book] about her would be a perfect way to honor her," Evan said. Matt took a different approach in his memoir, My Life. Instead of recalling a memory, he imagines what the future may hold and details his aspirations of moving to Los Angeles to become an actor and singer. Devery, who Jocelyn called a prolific writer, centered her memoir on a more emotional topic - the cause of her disability. In I Fought My Way in

*Life*, she tells the story of how her life was forever changed after being involved in a car accident at age two. Although a painful story, Devery enjoyed the writing process. She said writing gives her a voice and allows her to express things she wouldn't otherwise be able to. "For me, writing is like a painting where you have nothing on paper, but in time, you will get a beautiful picture and writing is the picture," Devery said. "If I could write for a living, I would be in heaven!"

### Ice Skating at Mill Pond

The Parks and Recreation Department provides supervised ice skating at Mill Pond when the ice is thick enough and conditions allow for safe ice skating. Skate guards will be available to monitor the skating and keep a warm fire going.

When the pond is posted as "no skating", it is imperative that people do not go on the ice. The pond may be closed due to cracks, insufficient thickness, rough ice, or snow cover. The Parks crew tests the ice thickness daily, and when it is determined to be the proper thickness, the Parks and Recreation Director makes the decision whether or not to open the pond for skating. The crew clears the snow from the ice after they finish clearing snow from 2 miles of sidewalks and town parking lots. "Sometimes people think they are helping by trying to clear the snow from the ice. This can actually make the conditions worse because they do not push the snow all the way to the edges. Last winter, someone cleared a small area, and the piles of snow they left on the ice froze there and our crew could not move it. It caused the skating to be closed for the season earlier because the skating area was ruined," according to Parks and Recreation Director Rick Maynard.

When the pond is open, a sign is posted at the edge of the parking lot.

As the weather turns colder, people may call the Parks and Recreation office at 203-453-8068 or the weather line at 203-453-8134 to determine if the schedule for the pond is open.
