



On the opposite side of the ledger is the sad fact that the State of Connecticut has yet to pass a budget. While the Town of Stonington, working collaboratively with its three Boards - Selectmen, Finance and Education - passed its municipal budget on a two to one vote in May, we still do not know what the state will provide in municipal aid. This situation promises long-term issues for Connecticut's 169 towns and cities; and means that we will have to be increasingly self-dependent in managing our revenues and expenses. While our non-partisan approach of working together collaboratively for the good of the town seems to be working well, the problems of the state promise additional burdens in the future.

Another problem arose with an infestation of rodents due in part to several warm winters and to those individuals who have been wittingly or unwittingly providing food sources and harborage. Stonington was very fortunate to have just signed an agreement with the Ledge Light Health District to provide our health and sanitation services. As a result we have had as many as four sanitarians engaged in a community wide canvass to identify the problem, notify the public and engage in remedial measures. For this, The Westerly Sun awarded us an editorial "High!"

Switching back to the good news, Stonington is lucky to have a number of long-serving highly competent town employees. One of these is our Town Clerk, Cindy Ladwig, who has served almost forty years in the Clerk's Office and has been Chief Clerk for 20 years. TAX EXEMPT ORGANIZATIONS

This is the year in which scientific, education, literary, historical, charitable, open space land preservation organizations, and cemetery property held in trust for a religious organization are required to refile for property tax exemption status. Exemptions granted apply to listed real estate, personal property and motor vehicles. Quadrennial forms will be mailed in September and are due on or before November 1, 2017. The forms require more detailed information than previously required to ensure qualification as tax exempt.

Organizations are required to state the purpose of the organization and provide copies of their charter and by-laws. Income sources are to be reported. The organization must list the provision of the Connecticut General Statutes under which they are claiming exemption. The documents should indicate where the assets would go in the event of the organization's dissolution. Officers, members, or employees may not receive any pecuniary profit from its operation; only reasonable compensation for services effecting one or more of its purposes.

An institution may qualify whose properties and assets are pledged in perpetuity to the relief of persons in financial need and to their assistance in obtaining the care they must have to prevent their becoming a burden on society.

The institution may also be one whose properties and assets are pledged in perpetuity to the relief of persons in financial need and to their assistance in obtaining the care they must have to prevent their becoming a burden on society.

In the event a portion of an organization's property is rented it must also be provided on the quadrennial form. If a non-profit organization is leasing to another non-profit organizations both organizations are required to file for tax exempt status.

The following are a listing of documents to support the tax exempt status:

- IRS document (most recent) recognizing the organization as tax exempt under 26 U.S.C. Sec. 501 (c) or 501 (d).
- State of Connecticut Sales Tax Exemption.
- Evidence that corporation has timely filed its biennial return naming officers & directors with the Secretary of State.
- Certificate of Need from Connecticut Office of Health Care Access.

- Certified copy by authorized officer of corporate charter and by-laws or good faith equivalent if applicant is not corporation.
- Signed federal and/or state income tax returns, with all schedules attached for most current year.
- Audited financial statements for the latest available year.
- Description of each source of revenue, e.g. rents, fees, grants, charges, gifts, donation and the like, generated by or for each use of all real and/or personal property.
- Description of all uses of real and/or personal property, owned or leased, of which an exempt activity is a part, whether or not exemption is requested for any such use or uses.
- Personal property declaration for the current year **REQUIRED ANNUALLY** and complete listing of all Connecticut registered motor vehicles.
- Copies of funding requests made to public institutions or private parties in the current tax year and prior tax year of the applicant.
- Evidence of compensation in money or in-kind paid to officers, directors and/or employee of the applicant.
- Evidence that the property is used as claimed

Though religious organizations are not required to file a quadrennial form, except for cemeteries, any property owned that is rented or leased personal property is required to be reported.

Failure to file in a timely manner will result in the removal or denial of tax exempt status. "Exemption from Taxation is equivalent of appropriation of public funds because the burden of the tax is lifted from the back of the potential taxpayer who is exempted, and shifted to the backs of others." Snyder vs. Town of Newtown, 147 Conn. 374 (1960)

Organizations that failed to file timely may be granted an extension of time to file if request is made within sixty days of the filing deadline (November 1st) and have submitted proof of substantial compliance and the required report forms. The request must accompany a late fee of thirty-five dollars.

Greetings from the Town Clerk's Office

June and July were busy months in the Clerk's Office. Along with all of our other duties, it was dog license time. We registered 1,675 dogs. Now that's a lot of dog treats! Please note that the delinquent dog list is turned over to the Animal Control Officers in August. They will start to canvass the list, so make sure you register your dog or you are subject to a fine.

This year the Municipal Election is Tuesday, November 7. The offices up for election are First Selectman, Selectman, Town Clerk, Town Treasurer, Tax Collector, Board of Finance, Board of Education, Board of Assessment Appeals and Constables. If you are unable to go the polls because you're going to be away or are ill or physically disabled, you can call my office 860-535-5060 or download the absentee ballot application from the Town Clerk's webpage. Under links, click on Absentee Voting and you can download and complete the application. Absentee ballots become available Friday, October 6. You can complete the application any time and we will keep it on file until ballots become available. Parents, remind your college students to complete an application before they go back to school or as soon as they know their mailing address. In CT all absentee ballots are counted on Election Day. If your ballot arrives after Election Day, it is never opened or counted.

Did you know there is a permanent absentee ballot application if you are unable to go to the polls because you are ill or physically disabled? You will need to request a doctor's note stating that you are unable to go to the polls because of your illness or physical disability. Just complete the absentee ballot application and send it in with the doctor's note and a ballot will be sent automatically for every election. It's that simple!

In June I had the honor of being recognized by the Board of Selectmen for 40 years of dedicated service to the Town of Stonington and for my forthcoming 20th year serving as your Town Clerk. It has been an honor and a privilege to serve the citizens of Stonington and look forward to another four years.



Human Services - Parks & Recreation

Stonington Recreation REC serves as an advocate for meeting the recreational needs of all the residents within the Town of Stonington. The division, within the Human Services Department, provides youth and adults an abundance of seasonal and year-round recreational opportunities to participate in camps, clinics, leagues, open runs, trips, family movie nights and fitness programs.

SPELLMAN RECREATIONAL PARK

JUVENILE REVIEW BOARD

The purpose of the Juvenile Review Board (JRB) is to provide an alternative to Juvenile Court for juveniles who have committed minor criminal violations in Stonington, and to assist youth who have exhibited problems in the home, school, and community. The goal is to provide a plan for each individual by utilizing community programs, services, and other resources, which will effectively deal with the particular incident, assist in positive development, and encourage responsible behavior.

FAMILY WITH SERVICE NEEDS REVIEW BOARD

Families with children who are engaging in risky behaviors such as running away from home, school truancy, and defiance of family or school rules often rely on state operated programs to help address these problems. The state of Connecticut has defined such children and parents as a Family with Service Needs (FWSN). Beginning in 2005, Connecticut began enacting a series of legislative, policy and procedural changes to address **continued on page 12**

these issues. These changes were grounded in the belief that swift, community-based family services were the best approach for Families with Service Needs. The new approach to at-risk youth and families rejected the use of the justice system as the first response to FWSN cases. Research demonstrates that these behaviors are strong predictors of continued involvement with juvenile, criminal and child welfare agencies. Therefore, intervening with appropriate services at an early stage is crucial to reducing future involvement with the justice systems. Based on a need in the community, in 2015, Stonington Human Services and the Stonington Public School District, in collaboration with the Stonington Police Department, Juvenile Court and DCF, developed a Family with Service Needs (FWSN) Review Board. The purpose of the Board is to intervene and divert at risk children from the entering the court system. The Board recommends diversions that encourage positive, pro-social development, school attendance, family engagement and participation in community-based programs.




Stonington Prevention Council PRESCRIPTION DRUG DROP

BOX AT THE STONINGTON POLICE DEPARTMENT

Do you have unused, unwanted or expired medications? Sponsored by Stonington Prevention Council in 2015, the Stonington Police Department installed a permanent Prescription Drug Drop Box in their main lobby - hundreds of pounds of medication have been collected since then! How can Stonington Human Services help you? Call for more information or to make an intake appointment. During the appointment, you will be screened for a wide variety of federal, state and local programs that may be able to assist your situation. Home visits are available for housebound residents.

DO YOU QUALIFY FOR ENERGY ASSISTANCE?

Stonington Human Services has been a local fuel bank for the last seventeen years, participating with Operation Fuel, TVCCA, and United Way energy assistance grant programs. Income guidelines for TVCCA's programs cap at 60% of the State Median Income (CHAP). Assistance amounts are based on established guidelines regarding family size and vulnerability. For example, a household of four qualifies if their total income is no more than \$66,089. Now accepting applications! Deliveries do not start until November 15, 2017 and will continue until March 15, 2018. Call 860-535-5015 for an appointment.

Operation Fuel and United Way also offer energy assistance programs in an effort to help keep folks warm during the cold winter months, avoid power shutoffs, and address other crisis situations when the TVCCA program has been depleted or in other circumstances where a family may not have been eligible. Guidelines for these programs are also adjusted each year with changes in the economy. Contact Human Services for more information and an appointment. Residents with Eversource "metered" heating services (electric and natural gas service) are also eligible for heating assistance. In addition, applicants who have been approved for the TVCCA program (both CEAP & CHAP) are eligible for the Matching Payment Programs (MPP) offered by these companies. The program puts those qualified on a budget plan and will match all payments made during the winter heating month (November through April) dollar for dollar in an effort to reduce the customer's balance to zero. Human Services can help with these programs as well as a low-budget worksheet that may reduce the monthly payment even more. MPP begins each year on November 1st.

SUCCESS COACHING

The program limits annual income to \$35,200 for an individual and \$42,900 for a married couple. There is no asset rule for this program. IMPORTANT NOTE: Be sure to update your Yellow Dot and File of Life information as your medical needs and prescription drugs change.

CT HOME CARE FOR ELDERS

This CT Department of Social Services program assists the elderly by providing the support services needed so they may remain in the community, rather than in a long-term care facility. "To be eligible, applicants must be 65 years of age or older, be a Connecticut resident, be at risk of nursing home placement and meet the program's financial eligibility criteria. To be at risk of nursing home placement means that the applicant needs assistance with critical needs such as bathing, dressing, eating, taking medications, toileting. The CHCPE helps eligible clients continue living at home instead of going to a nursing home."

MEDICARE INSURANCE COUNSELING (CHOICES)

Human Services has an experienced CHOICES counselor on staff offering personal & confidential appointments for Stonington residents to discuss Medicare options, supplemental insurances, Medigap policies, HMOs, "special help" for Medicare Part D, Medicare Buy-in programs, state pharmaceutical programs, Social Security, and more. Home visits are also available for residents who are homebound.

Are you confused about the difference between Medicare Part C (Medicare Advantage Plans) and supplemental insurance plans (Medigap Insurance)?

- Do you need help navigating through the various CHOICES in plans and services?
- Would you be interested in knowing if you are eligible to have your Part B premium paid through the Medicare Savings Program?
- Did you know that you may be able to get half of your spouse's Social Security and build value in yours while you continue to work past your full retirement age?

First and foremost, be careful! Much of the mail you are receiving (if you are approaching retirement age) may look "official," but may actually be advertising. Seniors have reported getting phone calls from people they do not know soliciting "Medicare" programs. Be safe! Contact us for the information you need regarding your Medicare programs.

MEDICARE SAVINGS PROGRAM (MSP)

You may be eligible to have your Medicare Parts B and D premiums paid for you! Medicare Part B, the part of your Medicare that pays your doctor's visits, out-patient testing, etc. costs \$134/month. Medicare Part D premiums for your prescription drugs vary depending on the plan you choose. Both are required unless the Medicare beneficiary has creditable coverage through employment, a retirement plan, VA, or other "credible" plan. The State of CT offers a program called the Medicare Savings Program (MSP) that will pay these premiums for income qualified seniors.

So, where can you apply? Stonington Human Services has the application for this program, as well as trained staff to help; because it is a "self-declared" program, the application is the only paperwork needed. DSS will check all income through the appropriate state and federal agencies.

The towns of Bozrah, East Lyme, Griswold, Groton, Ledyard, Lisbon, New London, North Stonington, Stonington, Preston and Waterford collaborate with the Eastern Connecticut Transportation Consortium and the CT Department of Transportation to expand transportation services to individuals age 60 and over and disabled adults. To keep services running smoothly, please follow the guidelines outlined below.

Who qualifies for this program? This program is open to individuals who reside in the above listed towns, meet the residency requirement described below:

- To utilize the brokered rides portion of the service you must have completed a registration form, and have submitted the annual membership fee payable to your participating senior center or municipality. Individuals residing in: Private Homes; Retirement Living Facilities; Independent Living Facilities; Assisted Living Facilities; and Residential Care Homes are eligible for transportation under this program.
- Individuals who reside in Skilled Nursing Facilities are not eligible for transportation through this program.
- Individuals who are eligible for free transportation through Medicaid are asked to use that program instead.

If you wish to just access the Caregiver portion of the program you still must complete the registration but do not have to pay the membership fee.

What are the limitations of this program?

Brokered rides are provided for medical appointments in New London County/Westerly, RI. Rides are contingent upon available funding. Reservations must be made no later than 48 hours in advance but can be scheduled up to 2 weeks ahead. Trips can be scheduled during normal business

hours. Requests for weekend & Monday trips must be made no later than Friday by 2 pm. Personal Care Attendants (or family member acting as an escort) may accompany passengers who need extra help with entering and exiting the vehicle or have other needs that make traveling independently unsafe. In order to protect the health of others, passengers must be free from acute illnesses such as flu, fever, vomiting, diarrhea, and infections such as pneumonia.

What information should I have when calling to request a ride?

- Your complete name and address.
- The address of your destination and the physician's name.
- The date and time of your appointment.
- An estimated time that you will be picked up from your appointment to return home.

How does the Caregiver Mileage Reimbursement Program work?

The rider retains a volunteer driver (friend, neighbor, family

member). The driver and rider must complete the "Request for Mileage Reimbursement" form. Mileage is calculated by ECTC based on the shortest distance to the destination. The mileage from the caregiver's home to the passenger going to the medical appointment is NOT included. Form must include appointment date, start address, destination address, and must be signed and dated by client and driver after last trip has been entered on the form. Participants submit completed mileage reimbursement forms to their town senior center or town representative by the end of the month for processing.

When the form is submitted, the town representative reviews the form for accuracy and verifies the mailing address of the Caregiver. Town Representatives may perform audits to verify that the appointments did occur. The Town Representative will sign and fax form to ECTC. ECTC will issue a check to the Caregiver for authorized trips performed. Call or stop by Stonington Human Services for a registration packet.



Advice for Executors

The Top 5 Things to Do the First Week After Someone Passes Away

- 1. Monitor the home.** Keep an eye on the decedent's home, answer phone messages, collect mail, discard food, and water plants. If necessary, change the locks. Don't give away any personal property in this first week.
- 2. Arrange for burial or cremation.** Search the decedent's papers to determine whether they have a prepaid funeral contract or burial plan. Decide how you will pay for the funeral and memorial service. Unless the decedent made you the joint owner of a bank account, you and close family will need to front these costs and get reimbursed from the estate.
- 3. Prepare the funeral service.** In some religious faiths, the funeral service occurs soon after death. Find any directions from the decedent in this regard. Visit with the clergy member to review the service. Prepare remembrances and gather photos for the wake and the funeral reception. Contact the restaurant or other venue at which you want to hold the reception. If appropriate, write a eulogy or delegate this task to someone.
- 4. Prepare an obituary.** It will mean a lot to the family if you take the time to prepare an obituary well. Send the obituary to the local newspaper.
- 5. Gather Important Documents.** Get at least 10 original death certificates. The funeral home will usually order these certificates for you. Find the Will, any Trust Agreement, the latest bank account statements, investment statements, deeds, birth certificate, marriage certificate, divorce decree (if any), Social Security information, life insurance policies, certificates of title to vehicles and keys to the safe deposit box or home safe.




